- 1.1 To advise Members of that WORCESTERSHIRE COUNTY COUNCIL has issued a Public Notice to advise of the temporary Road Closure of Enterprise Way, Evesham
- 1.2 **Proposed Order:** to close that part of U44695 Enterprise Way from its junction with Conference Way (Private) for a distance of 50 metres in an Easterly direction.
- 1.3 **Reason:** Replacement electricity cable by Western Power Distribution.
- 1.4 **Exemptions:** to permit access to any land or premises fronting the highway affected where there is no other form of access; and to allow the works to be undertaken.
- 1.5 **Alternative route:** U44695 Enterprise Way (part), U44692 Millennium Way, U44694 Crab Apple Way, U44695 Enterprise Way (part) and vice versa.
