#### 7. Castle Street Slipway

The Town Clerk had circulated a report regarding the slipway at Castle Street. It had been confirmed that the encroachment was limited to the area of block paving and did not include the tarmac parking area which did not belong to the council. The developer would be contacted regarding the encroachment on the block paving.

#### 8. Re-surfacing paths in Waterside Cemetery & All Saints Churchyard

The tarmac paths in Waterside Cemetery and All Saints Churchyard were in a poor state of repair with potholes and cracks. There had been reports of members of the public tripping and falling at each location. The area of paths was extensive, so it was proposed to carry out an ongoing programme of repair, starting with the most dilapidated areas. Maps of these locations and costs for repair had been circulated to committee members. Two phases of work were recommended, with Phase 1 being a critical priority. Phase 2 would be considered at a future meeting with a view to it being scheduled in the next 18 months to two years, and the remaining sections of path carried out in an ongoing programme.

Three companies had quoted for the works.

It was resolved to make a recommendation to council that the Phase 1 work take place as soon as practicable, and to recommend Company 3 to carry this out.

# 9. Fencing at Hampton Playing Field

The fencing alongside Hampton Playing Field was in a state of significant disrepair. Cllr Kimberley had been active in acquiring quotations from contractors to replace the fencing in the same style.

Four quotations had been received. It was resolved that the work should go ahead and Company 1, who had offered the most competitive price, should be engaged to do the work, subject to the wood quoted for being treated wood.
