#### 6. Town Hall – Painting

The Town Clerk had circulated a report with the agenda regarding the painting of the interior of the main hall, stairs and landing of the Town Hall. Attached to the report were 4 quotes. Following consideration, it was agreed that the specification of the work be formalised to ensure consistency in quoting from the contractors. Cllr P Griffiths would assist with the specification for the works. There was a desire to update the colour scheme; an interior designer would be contacted to put forward designs.

# 7. Snap Frames in the Town Hall

The Town Clerk had circulated a report with the agenda regarding a request from The Evesham Arts Association (EAA) to install snap frames in the town hall foyer and up the staircase to advertise their upcoming events. When not in use by EAA the town council could advertise other events in the town hall, or even promote the use of the town hall. It was resolved that given the hall was to have a makeover (see minute above) the interior designers to be engaged in looking at ways of using snap frames but in a design more in keeping with the town hall.

# 8. Traffic Regulation Orders – Proposed amendments to waiting restrictions.

The Town Clerk had circulated a report with the agenda regarding proposals by Highways to make amendments to the waiting restrictions on Abbey Lane and Abbey Road. It was proposed that Abbey Lane which was currently "no waiting 8am to 6pm" be "no waiting at any time" and that Abbey Road be altered to "no waiting at any time". Following debate, it was resolved to support the "no waiting at any time" on Abbey Lane, but the proposal for "no waiting at any time" in Abbey Road not be supported, but to put forward a proposal to amend the regulation to restrict parking to 2 hours.

There being no further business the meeting was closed at 8.00pm.
